"Coloniality, raciality, punishment and reparation in the Americas, 19th-21st centuries"

Extension of the deadline for Working Groups (WGs) proposals and other announcements

Dates: November 27-30, 2024

Venue: University of São Paulo (IEA-USP), Brazil.

The Organizing Committe for the International Conference on "Coloniality, raciality, punishment and reparation in the Americas, 19th-21st centuries" informs that the deadline for submitting proposals for Working Groups (WGs) has been extended until June 1st, 2024.

We would like to remind you that the WGs may have up to four 1.5-hour sessions spread over the days of the International Conference. The goal is to welcome collective and individual works and foster fruitful exchange between researchers and social movement activists.

WGs may be coordinated by up to three people. The proposals must include a description of the participant(s) and their institution(s), a short description of their CV or academic records, an abstract of no more than 500 words, and a short list of bibliographic references, thus revoking the previous requirement of holding a doctorate to propose WGs.

Submssions of proposals for **mini-courses** remain open until July 15th, 2024. The goal of the mini-courses is to present, in a didactic and provocative way, experiences and reflections of the relationship between coloniality, raciality, punishment, and reparation. The target audience will be undergraduate and graduate students and social movement activists.

The mini-courses will take place over up to four 1.5-hour sessions spread over the four days of the Conference. We ask the proponents to submit a summary of the classes with up to 500 words and a short reference list. Academic qualifications of the proponents will not be required.

The **WGs and mini-courses** must be aligned with the following **Thematic axes**:

- **1.** Coloniality and raciality as devices of punishment.
- 2. Coloniality, raciality and punishment in the formation of borders
- **3.** Strategies of insurgency: decolonizing and de-racializing punitive systems in the Americas
- **4.** Memory, justice, and reparation
- **5.** Gender and punishment
- **6.** Insurgencies in the Americas: from anti-slavery struggles to struggles for rights
- 7. Coloniality and raciality as social markers for Reparations and Justice

Accessibility: all facilities are adapted to accommodate people with reduced mobility.
